The new User Bulletin is designed to assist YOU in the use of your CROMEMCO products. The bulletin will be released periodically with information regarding hardware revisions, software updates, trouble-shooting and service hints.

* * * NEW CDOS * * *

CROMEMCO is pleased to announce the release of an enhanced version of CDOS. This release includes features such as CDOSGEN and a method of defining the value of the function keys on CROMEMCO's Model 3101 terminal.

CDOS-CP/M COMPATIBILITY

The Cromemco Disk Operating System (CDOS)* is an original product designed and written in Z8Ø machine code by Cromemco, Inc. for its own line of microcomputers. However, due to the large number of programs currently available to run under the CP/M** operating system, CDOS was designed to be upwards CP/M-compatible. Cromemco is licensed by Digital Research, the originator of CP/M, for use of the CP/M data structures and user interface. This means that most programs written for CP/M (versions up to and including 1.33) will run without modification under CDOS. This also means that programs written for CDOS will not generally run under CP/M.

There are several advantages to end-users which result from this compatibility. First, users of Cromemco machines are able to draw on the large library of existing CP/M and CP/M compatible

programs available on the market. Second, users familiar with CP/M can easily move up to CDOS taking advantage of the many additional features available with CDOS.

The enhancements contained in CDOS but not CP/M are primarily visible in the system calls. CDOS has added a number of new system calls to allow the user even more flexible means of device and disk I/O. System calls are in all cases executed by first loading the C register with the number of the call. In the case of the non-CP/M calls, the parity bit of the 8-bit quantity in C is set to allow for a new range of 128. This is apparent in the Summary of CDOS System Calls.

This new CDOS is a valuable addition to our software capabilities, and is easily interfaced to existing CROMEMCO software packages.

As an added bonus, this is an opportunity to bring your software library up to the latest revision levels. The appropriate software will be included with your copy of CDOS at no additional charge.

The package includes:

- 1. CDOS User Manual
- 2. Floppy Disk with:
 - A. New CDOS
 - B. Standard Utilities
 - C. Latest revision of System Software i.e. Basic, Cobol, Fortran, etc. (additional manuals may be purchased separately).

To obtain your copy, you must have the proper software registration forms on file with CROMEMCO. In addition, in order to update our files, and to comply with copyright law, you must fill out and return with your order, the enclosed Software License Agreement. When filling out these forms, please print or typewrite all information except where a signature is required. This will help us to speed delivery of your order.

CROMEMCO APPLICATIONS NOTE Rev. C 4FDC Board Corrections

REV B OK

Please note that a jumper wire should be installed on all Rev. C 4FDC boards from pin 19 of IC 14 (74LS240 or 74S240) to ground (available at either pin 1 or pin 10 of IC 14). This correction grounds the chip-enable line for the output bus drivers, which prevents incorrect disk-restore operation of the 8" drives.

This problem will most likely occur with the new CDOS (versions $\emptyset1.00$ and higher), because the restore for fast seek drives is now done by a more accurate method in software. A symptom of the problem is the message:

Read Error: Drive A, Track 02, Sector 01, Status=10 which occurs when attempting to boot new CDOS.

A second correction which should be made to all revisions of 4FDC boards is to substitute a 4.7K resistor network as RN2 in place of the 1K network presently used. These resistors are used as pull-ups to the +5v. line and the incorrect 1K networks sink too much current, which may result in CRC errors on disk operations.

Please check your kit or wired 4FDC for this $4.7 \, \mathrm{K}$ network (RN2), and note that both the silk-screened board legend and the 4FDC manual may be printed with the incorrect value.

Dear CROMEMCO Customer:

CROMEMCO now requires a return authorization number for any return of equipment for repair, replacement or credit. This number will be issued by the Customer Support Department. Any equipment received without the return authorization number clearly marked on the outside of the package will be immediately returned to the sender.

Effective September 1, 1978 repair of all kit and nonwarranty boards will be \$70.00.

Returns for credit will be subject to a 15% restocking charge.

If a Persci drive is returned without the head loader card correctly inserted for shipping, the warranty will be void. Persci drives are extremely sensitive to shock, so please be careful to insert the head loader card properly. Disk drive nonwarranty repair charges range between \$100.00 and \$350.00.

SOFTWARE LICENSE AGREEMENT

IMPORTANT: READ THIS LICENSE AGREEMENT CAREFULLY BEFORE OPENING THIS PACKAGE. IF YOU DO NOT AGREE TO THESE TERMS, RETURN THIS CROMEMCO SOFTWARE PACKAGE UNOPENED TO YOUR DISTRIBUTOR AND YOUR LICENSE FEE WILL BE REFUNDED.

CROMEMCO Software is licensed by CROMEMCO to customers only on the condition that the Customer agrees to the terms set forth in this agreement. If you agree to these terms, you must fill out the registration form on the opposite side and return it to CROMEMCO by mail before using the enclosed CROMEMCO Software. This License Agreement applies to all CROMEMCO Software. "CROMEMCO Software" includes the object code for CROMEMCO Software computer programs, whether supplied on an 8-inch or 5-inch floppy diskette or any other medium, and all associated documentation provided by CROMEMCO.

- 1) License. CROMEMĈO agrees to grant and the Customer agrees to accept on the following terms and conditions a nontransferable and nonexclusive license to use the CROMEMCO Software enclosed with this agreement.
- 2) Restrictions on Use: This license authorizes the Customer to use the CROMEMCO Software programs in object code form only and only on the single CROMEMCO computer system designated on the Customer's registration form. A separate license is required for each system on which CROMEMCO Software is to be used. The customer may not use CROMEMCO Software or any part thereof on any equipment other than a CROMEMCO computer system. Neither the license granted under this agreement nor the CROMEMCO Software to which it applies may be assigned, sublicensed or otherwise transferred by the Customer without the prior written consent of CROMEMCO.
- 3) Back-up Copies of Programs: The Customer may make back-up copies of CROMEMCO Software programs as required for Customer's own use only, provided that the Customer must maintain appropriate records of the number and location of all such copies. The original and all copies of CROMEMCO Software programs, or any part thereof, made by the Customer shall be the property of CROMEMCO. This does not imply, of course, that CROMEMCO owns the media on which the programs are recorded.
- 4) Copies of Printed Materials: The Customer may not copy, in whole or in part, any CROMEMCO Software program, documentation or related materials provided by CROMEMCO in printed form. Additional copies of such printed materials may be obtained from CROMEMCO at CROMEMCO's standard published rates.
- 5) Permitted Modifications: The Customer may modify the machine readable form of a CROMEMCO Software program to adapt it to operate with a terminal or line printer device not supplied by CROMEMCO. No other modifications may be made to CROMEMCO Software without the express written permission of CROMEMCO. CROMEMCO will not provide any support for CROMEMCO. COSOftware that has been modified by the Customer.
- 6) Copyright Notices and Legends: CROMEMCO Software is copyrighted by CROMEMCO and, in some cases, by CROMEMCO's software suppliers. The Customer agrees not to remove any copyright notices or any confidential or proprietary legends from any CROMEMCO Software, and the Customer agrees to reproduce such notices and legends on any copies or modifications of CROMEMCO Software made by the Customer as permitted herein.
- 7) Nondisclosure: The Customer agrees not to provide, disclose or otherwise make available any CROMEMCO Software to any person other than the Customer or its

- employees for purposes necessary to the Customer's use of the CROMEMCO Software as authorized herein. The Customer further agrees that all copies of CROMEMCO Software will be strictly safeguarded against disclosure to or use by persons not authorized by CROMEMCO to use such CROMEMCO Software and that the Customer will take such steps as are necessary to insure that the provisions of this agreement are not violated by any employee of the Customer. The Customer recognizes that any unauthorized copying or disclosure of CROMEMCO Software will cause great damage to CROMEMCO and that this damage may greatly exceed the license fee paid by the Customer and that injunctive relief may be appropriate to prevent such unauthorized copying or disclosure.
- 8) Term: The license granted under this agreement is effective from the date on which the Customer opens this CROMEMCO Software package and shall remain in force until terminated as provided below. The Customer may terminate this license at any time upon one months' written notice to CROMEMCO. CROMEMCO may terminate this license at any time if the Customer fails to comply with any of the terms of this agreement.
- 9) Termination: Within one month after the date of termination of the license granted under this agreement, the Customer will furnish CROMEMCO a certificate certifying that through the Customer's best efforts, and to the best of the Customer's knowledge, the original and all copies, in whole or in part, in any form, of the CROMEMCO Software have been returned to CROMEMCO or destroyed.
- 10) Enhancements and Updates: From time to time, CROMEMCO may advise customers who have completed registration forms and returned them to CROMEMCO of enhancements and updates to the CROMEMCO Software. Upon written request of any such registered Customer within one year from the date of the Customer's receipt of the CROMEMCO Software, CROMEMCO will provide the Customer an updated version of the CROMEMCO Software for a nominal copying charge.
