Three types of switch registers:

- Accumulative Registers *UNTIL POLLING IS DONE
HOW MANY CFS/M*
 - Are event-driven
 - Accumulate data until a poll occurs
 - Reset to zero once polled

- Peak Registers *REPORTS
TRKS*
 - Collect CCS (centum call seconds) or peg-count data
 - Collect highest hourly data over the polling interval
 - Collect hourly and compared to corresponding previous peak
 - Replaced with current hourly value if greater than the current peak stored
 - Have multiple time-coincident registers associated with it

- Time-coincident Registers
 - Collect CCS or peg-count data
 - Associated with one or more peak registers
 - Store traffic data for the same hour as the associated peak.

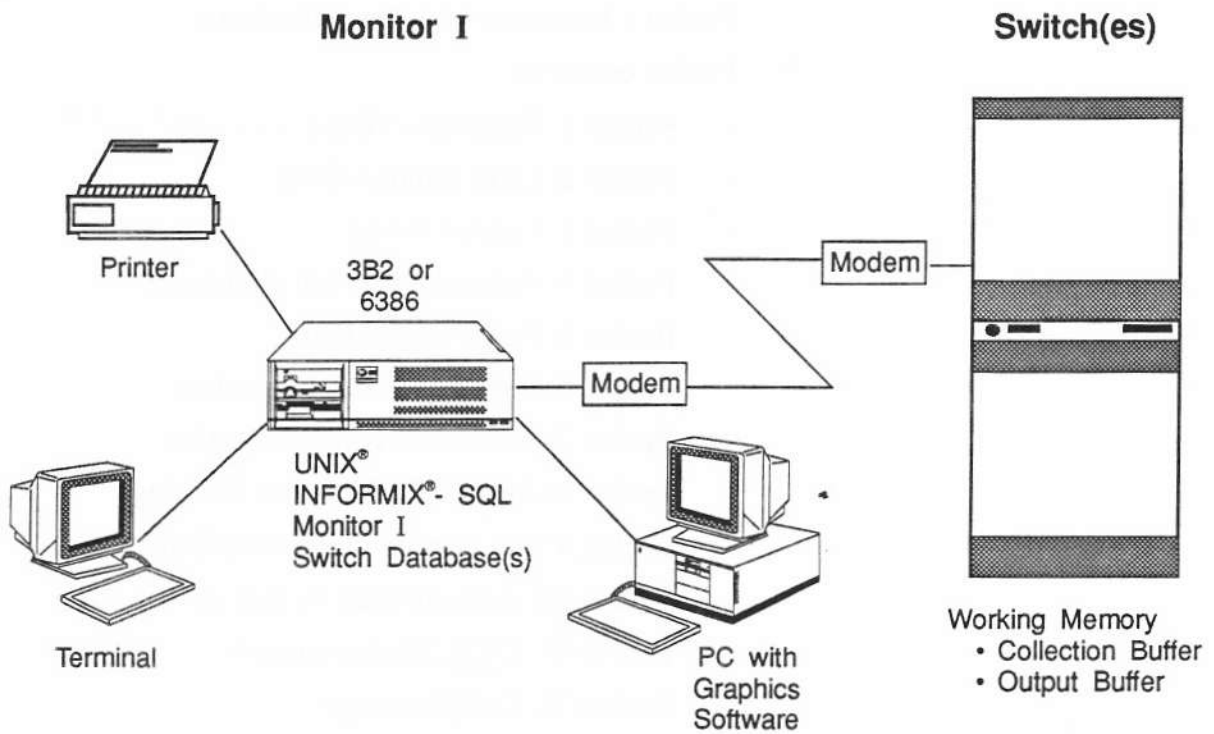
Monitor I Traffic Packets

Additional information can be found in the Operations Manual, Appendix B - Switch Traffic Data.

Data from the switch registers (Generic 2, System 85, and DIMENSION System) are organized into packets in the Monitor I database.

- Packets 4, 5, 6, and 10 are Monitor I *default* packets. *WENT FIRST TURNED ON!*
- Packet 1 is used to initialize a database.
- Packet contents:
 - Packet 1: Translation Data *will not see*
 - Packet 2: Load Balance Data
 - Packet 3: Carrier Usage
 - Packet 4: Automatic Circuit Assurance
 - Packet 5: Performance Data
 - Packet 6: Peak and Time Coincident
 - Packet 7: Automatic Route Selection
 - Packet 8: Automatic Alternate Routing
 - Packet 9: 100-Second Occupancy Data
 - Packet 10: Accumulated Values *FEATURES*
 - Packet 11: DCIU Measurements
 - Packet 12: Call Coverage
 - Packet 13: EUCD/ACD

DISCUSSION**Monitor I Polling and Storage Process**

- Collection Buffer^{WKNQ}
 - Stores data as it is collected by the switch
- Output Buffer
 - Holds data to being retrieved by Monitor I polling
 - Resets to zero
- Offset Time
 - Transfer data each hour from collection to output buffers
 - Add accumulative register values to corresponding values in output buffer
 - Compare peak register values with corresponding values in output buffer
 - Replace peak value in the collection buffer with the value currently stored in the output buffer (associated TC (Time Coincident) values also replaced)
- Poll Time
 - Retrieves data stored in the output buffer
 - Reset the output buffer values to zero

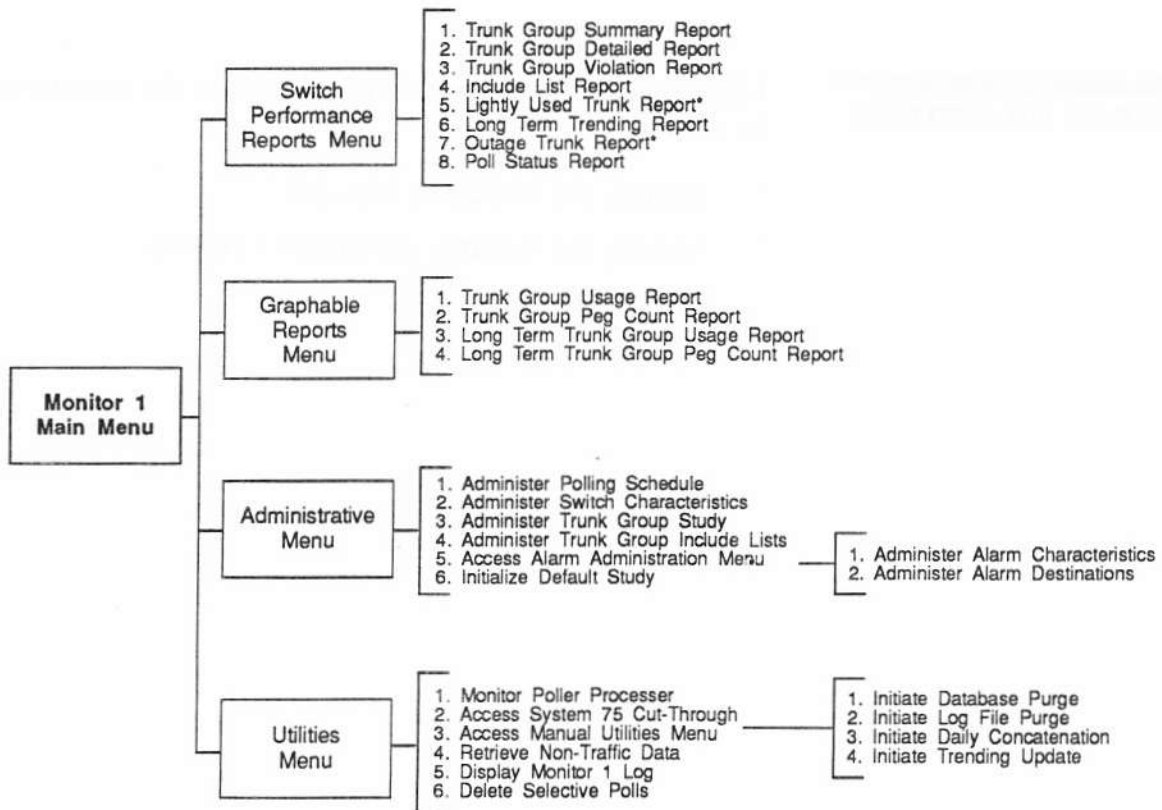

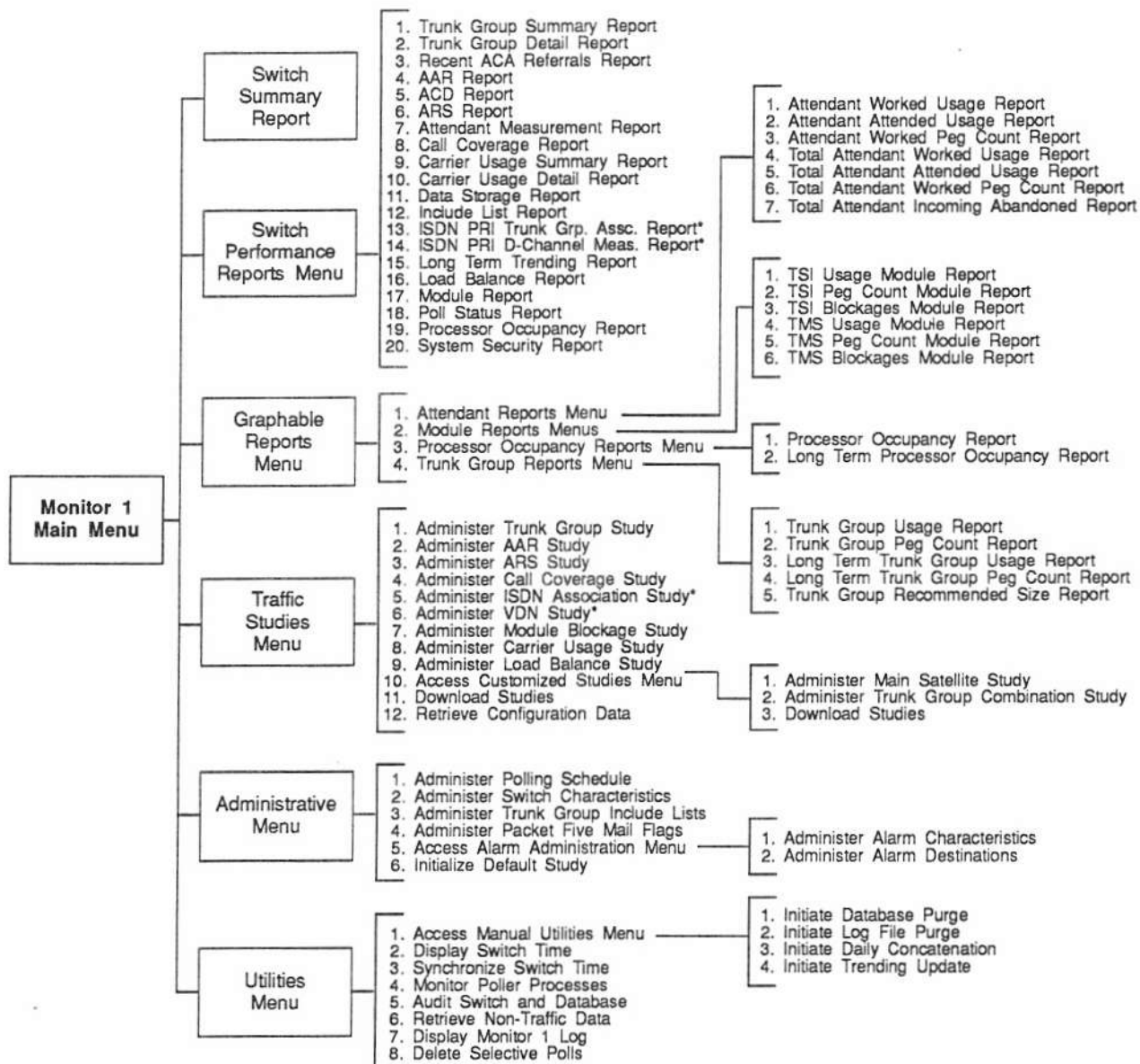

A separate INFORMIX® database is created on Monitor I for each switch Monitor I will support.

Monitor I connects to the switch, retrieves information, and sets up traffic studies.

Create Switch Database for Each Switch

- Enter database name at Enter target switch prompt
- Access to switch is authorized by AT&T during installation (all switches, G2 also requires agent IDs)
- Empty database is created
- Number of switches Monitor I can support depends on:
 - Hardware configuration
 - Database storage option chosen

See the *Planning and Configuration Guide* for details.

- Procedure must be performed again if another switch is added later

DISCUSSION**Initialize Switch Databases**

- Initialize Default Studies menu
- Database must be initialized before polling can be scheduled
- Monitor I connects to switch and populates TC tables with System Translations from Packet 1
- Data is gathered from List Measurement Trunk-Group screen (Generic 1 and System 75)
- Default studies set up for existing switch facilities
- Switch connected again to sequentially download default studies to switch in proc form (performed as a background activity)
- Re-initialization is not necessary however, initialization must be performed before the switch can be polled
- If extensive changes are made to telecommunications facilities, must reinitialize
- If audit reports show discrepancies, must reinitialize
- Failures and completion are indicated by UNIX® mail
- *mtmlog* tells the time and type of failure
- Types of failures include: connection failures, communication failures, or database related errors (unlikely)
- Do NOT attempt next step until initialization complete.

LESSON 2A - Initializing Traffic Studies

DISCUSSION**Activate Polling Control Mechanism**

Use *pollstart* command (only used at time of switch initialization unless Monitor I is turned off) to activate polling control mechanism

- Controls poller on all the switches supported by Monitor I
- Enables polling of all switches supported by Monitor I
- Known internally as *mtmguard*

Schedule Monitor I Polling for Each Switch

- Use `Administer Polling Schedule`
- Define how often to poll switches, which packets to poll, and which ports to use to gain access to switch data
- Default packets polled are 4, 5, 6, and 10
- Check that initialization is complete and polling control mechanism is activated (`ps -ef | grep mtmguard`)

- ISDN *6-5*
 - Study trunk groups with ISDN associations (Generic 2 switch)
- Load Balance *6-6*
 - Balance traffic volume across all modules
 - Minimize intermodule, least efficient call volume

- Module Blockage *M-9*
 - Provide traffic data on modules that make up switch
- VDN (Vector Directory Number) *6-7*
 - Study the VDN within the network (Generic 2)

Download Studies

- After a study is administered, the Download Studies transaction is run to transfer the study information to the switch.
- A mail message indicates when the download is complete.

Designate Different or Additional Packets

- Locate packet(s) in Appendix B - Switch Traffic Data.
- Change Administer Poll Schedule to designate different or additional packets.
- Should check 'Studies Currently Set Up' on the Switch Summary Report first. (It also lists packets currently polled.)

Rotate Switches

- Rotate polling among switches that were configured into Monitor I but are not currently being polled.
- Use *switch_dct* command to deactivate and *switch_act* command to activate.

Deactivate Polling Control Mechanism

Certain Monitor I maintenance routines, such as backups and upgrades, may require that polling be stopped for all switches.

- Stops polling completely
- Use *pollend* command

Stop Polling of Specific Switch

Stop polling of a specific switch will:

 - *Erlangs* = 3600 seconds or an hour of usage. 1 Erlang equals 36 CCS.
- Hourly or Daily
 - Most reports ask for hourly or daily figures.
 - If polling for the switch took place daily and user asks for an hourly report, the message "No data available" will be received.
 - If polling was daily and report requested for daily/all, the report will print the highest hour's values for each day polled.
 - If report requested for daily peak, report will print the highest hour for the highest day during the specified study period.
 - If polling was hourly and daily results are requested, report will be daily concatenated figure Monitor I has selected each night.
 - For peak registers, this figure represents the highest hourly value for each day.
 - Available only on reports that are concatenated.

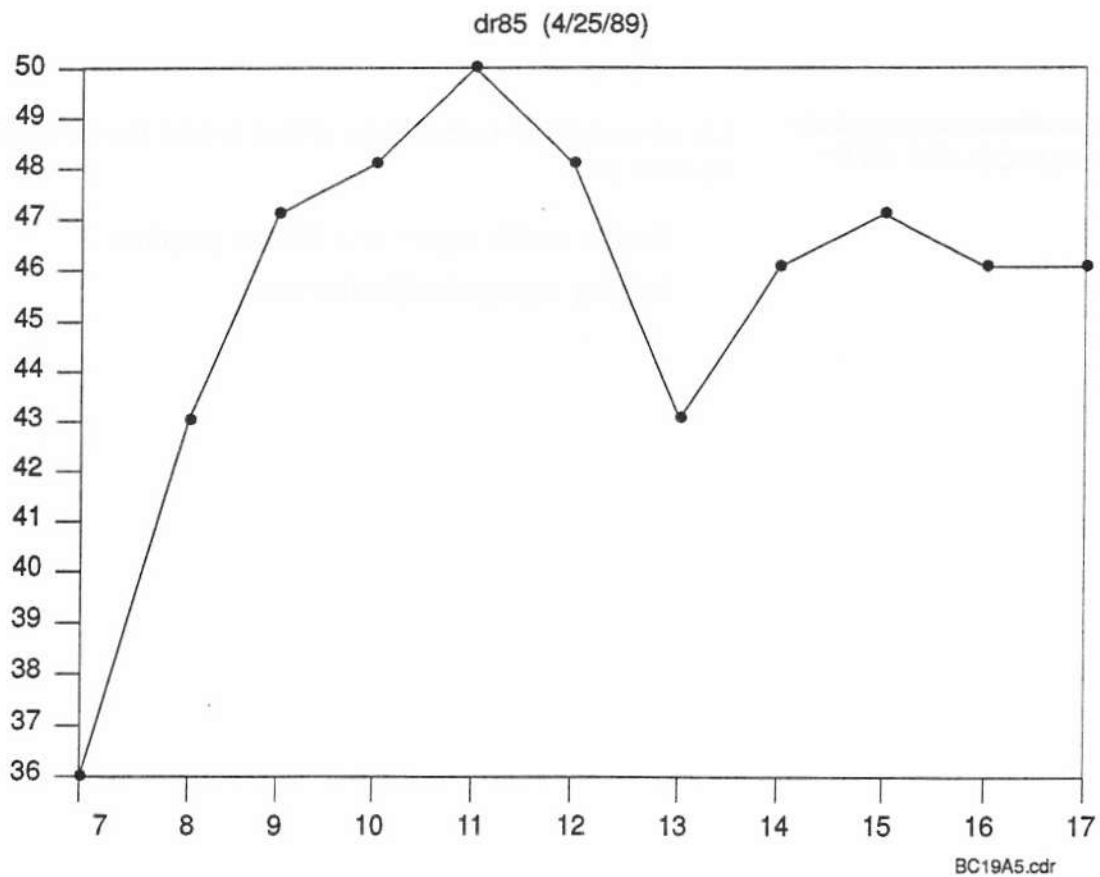

APPENDIX A

Traffic Management Glossary

TRAFFIC MANAGEMENT GLOSSARY

ABBH

See *Average Bouncing Busy Hour*.

Accumulative Register

Counts the number of occurrences of particular events, and monitors call activities.

Arrival Pattern

The way traffic arrives at a server group. Over an observation period (usually an hour), traffic arrives at a server group in one of three ways: smooth, random, or peaked.

Average Bouncing Busy Hour (ABBH)

One method of measuring average busy hour load of a system. ABBH is the average of the peak readings from each DAY of the study. It is used for a single server group.

Blocking

The percentage of service requests not immediately satisfied because of busy servers.

Buffer

A place in switch memory where data is stored. For traffic, a switch uses two types of buffers: collection and output.

Busy Hour

The period when there is the most traffic (calls in CCS - not the number of calls). The number of servers required is based on the average busy hour load.

CCS

100 seconds of server usage. Servers are scanned every 100 seconds. If the scan reveals the server is busy, it assumes the

server was busy the entire 100 seconds and measures one CCS. Maximum carried CCS load on a server group is equal to the number of servers times 36 (36 = 3600 seconds per hour/100).

Carried Load

A measure of how well the demand placed on the system was actually satisfied.

Collection Buffer

A place in switch memory where data is stored as it is collected by the traffic measurements program.

Data

Communication between data processing equipment connected to a system.

Delay

The average amount of time a caller must wait before a server becomes available.

Disposition of Blocked Calls

The most important variable influencing traffic model selection. It determines the number of servers required for a given traffic load and required service level.

Erlang

The international measure of usage for servers busy one hour.

Erlang B Model

A traffic model that is used for systems with random arrival pattern, variable or constant holding time, and blocked calls that are routed elsewhere. Common application includes first-choice trunk group with alternate routing configurations.

Erlang C Finite Queue Model

A traffic model that is used on systems with random arrival pattern, variable holding time, and blocked calls that are delayed or lost. Common application includes outgoing trunking with queuing.

Erlang C Infinite Queue Model

A traffic model that is used for systems with random arrival pattern, variable holding time, and delayed blocked calls. Common application includes attendant consoles and ACD agent positions.

Holding Time

The length of time a server is used to handle a call. When some calls have a relatively short and others have a longer holding, the holding time is variable. When every call lasts the same amount of time, the holding time is constant.

Neal-Wilkinson Model

A traffic model that is used on systems with random or peaked arrival patterns, variable or constant holding time, and blocked calls that are cleared. Common application includes last-choice trunk group in alternate routing configurations.

Offered Load

A measure of the demand placed on the system.

Output Buffer

A place in switch memory where data is transferred to from the collection buffer and held until it is retrieved by the polling device.

Packet

A block of related traffic measurements.

This method of organizing traffic data makes it easier to set up traffic studies and poll for desired data. At poll time, you can select which packets to retrieve.

Peaked Traffic

Incorporates large fluctuation in the number of busy servers at any given time. The more peaked the traffic, the more servers are required for a given traffic load and desired service level.

Peak Register

Stores the highest hourly data over a polling interval.

Peg Count

A record of the number of times events (usually calls) occur on a server group.

Polling

The process of retrieving traffic data from the switch. The measurements can then be analyzed.

Random Traffic

Traffic that arrives with moderate fluctuation in the number of busy servers at any given time. Random arrival pattern is the most common of the three arrival pattern types.

Register

A method of assignment for storing data. In traffic, there are three types of registers: accumulative, peak, and time coincident.

Retrial Model

A traffic model that is used for systems with random arrival patterns, variable holding times, and blocked calls that

require the user to try again. Common application includes stand-alone trunk groups.

Server

A facility that carries traffic load. Some examples include: trunks, attendant consoles ports, and lines.

Server Group

Servers are pooled so that server resources can be shared by users. A system can have many more users than it has servers to handle the traffic load.

Service Level

Describes how well the servers are performing.

Signaling

Information that gets a dial tone when setting up a call.

Smooth Traffic

Traffic that enters a server at a fairly steady rate. There is little fluctuation in the number of busy servers at a given time. Fewer servers are required with smooth traffic.

TCBH

See *Time Consistent Busy Hour*.

Time Coincident Register

Stores measurements associated with peak hour measurements. These registers capture more information about the traffic contributing to the peak hour.

Time Consistent Busy Hour (TCBH)

One method of measuring the average busy hour load of a system. TCBH is the average of the readings for the HOUR across the entire study that was busiest. It is used for determining the trunking requirements of alternate routing systems.

Traffic

The flow of information (or calls) through a communications system.

Traffic Measurement Program

Part of the switch system software that continually monitors the usage of traffic sensitive components in the system and stores the results.

Traffic Model

A mathematical representation of how a server group reacts under varying traffic loads and server quantities. Use of the appropriate model is necessary to predict service level given a traffic load and number of servers. Traffic models determine the server quantity required in order to handle a certain traffic load at a defined service level. The five models are: Erlang B, Erlang C Finite Queue, Erlang C Infinite Queue, Retrial, and Neal-Wilkinson Equivalent Random.

Usage

An indicator of the amount of time servers are busy. Two traditional units of traffic time measurement are CCS and Erlang.

Voice

Oral communication between users of a communications system.
